ICA conference returns home

After years of travel to Australia, Chile, and the Netherlands, the 2008 International CPTED Conference will return to Calgary, Alberta, Canada in the fall of 2008. This decision follows the cancellation of the Virginia conference this spring. Instead we will shift part of that spring conference focus to the 2008 Smart Growth Conference in Washington, DC, February 7th to 9th – an event the ICA has co-sponsored for years.

The fall 2008 conference is still in development. Details will appear on the ICA website in the weeks to come. Last December the ICA Board decided to revisit the mandate and services of the ICA. When the ICA was formed in 1996 there were few regional CPTED associations and no international voices for CPTED. Many services the ICA introduced over a decade ago are now provided by regional associations – a healthy development for the CPTED movement.

Times have changed. Today there are a healthy number of CPTED associations around the world. There is no doubt that the ICA has had a major role in helping that to occur. But the ICA cannot rest on its laurels. Thus, starting 2008 the association will redevelop its role to better serve the regional associations and CPTED practitioners around the world. Ideas for moving forward include expanding the ICA CPTED Certification program, launching a new e-learning basic CPTED course (already available on-line through our Latin American chapter), and promoting newer methods and theories on CPTED from our chapters around the world.

Watch for developments of the new ICA on the website in the weeks to come. $\Diamond\!\langle\!\langle\rangle\!\rangle$

safer by design

An evolving model in Virginia

For many years the efficacy of CPTED in development and redevelopment has been recognized by localities throughout Virginia, design professionals and associations and the Virginia Crime Prevention Association (VCPA). Programs on crime prevention and CPTED have existed since the late 1970's .They include:

- ➤ 1977 staff assigned to promote and support crime prevention at the state level
- ➤ 1978 a civilian planner hired on the Law Enforcement Assistance Administration (LEAA) grant to put together a "Criminal Justice Plan" for a locality,
- > 1978 the formation and incorporation of the VCPA.

In 1984, the Secretary of Public Safety directed the Department of Criminal Justice Services to organize and staff a public/private multi-disciplinary CPTED Committee to study how CPTED strategies could be implemented. The study produced a blueprint for CPTED policy in Virginia.

Safer By Design...

In 1994 the County of Henrico police department was one of the first in the nation to hire a civilian planner to focus solely on implementing CPTED to development and redevelopment in that county. Today Virginia can boast of having three localities with full-time planners devoted to the implementation of CPTED – City of Chesapeake, and the counties of Chesterfield and Henrico – as well as 15 other localities with civilian or sworn personnel reviewing site development plans from a crime prevention and CPTED point of view throughout Virginia. From this inclusive and proactive strategy in the 1970's and 80's, by 1994 the Zoning Enabling Legislation was amended to include *crime* within the zoning process. Adding the word "crime" to the Zoning Enabling Legislation spreads the burden of preventing crime beyond law enforcement. As Jane Jacobs so succinctly notes:

"The first thing to understand is that the public peace ... is not kept primarily by the police, necessary as police are. ... It is kept by an intricate, almost unconscious, network of voluntary controls.... No amount of police can enforce civilization where the normal, casual enforcement of it has broken down." [The Death and Life of Great American Cities, 1961, pages 31-32]

news from the UK

I am proud yet again to report that 2007 was another excellent year for DOCA. We have now been running since 1999 and have established ourselves as the premier source for any and all CPTED related business both in the UK and further afield. For the third year in succession membership has grown by about 15% to where we stand today with a total approaching 200.

This year has seen DOCA hold four seminars and travel to London, Birmingham, Milton Keynes and Liverpool. These seminars have attracted over 250 people and 20 speakers. One of these seminars was an International event held on 30th March. This event was supported by about 100 people and was in my opinion the best showcase that DOCA have provided to date. The speakers, despite some not having English as a first language, provided a new insight into how "designing out crime" is practiced outside of the UK. They came from many countries including the USA, the Netherlands and Estonia

In 2008 DOCA will continue to visit the far-flung corners of the UK and I am in discussions with EDOCA to try and organize a joint event in Holland.

What is professional development when it comes to CPTED? How can you enhance your CPTED skills and knowledge? The ICA certification program – the first of its kind in the world – answers those questions.

A recent email to people in the CPTED and security fields resulted in queries from a wide spectrum of interested people. One is from Pakistan, several are from the United States and Canada, another from Colombia (certification material is available in Spanish thanks to our great ICA members in Chile).

This program is not new, though few have heard about it. Certification is a way to clearly indicate that you are qualified and prepared to perform the duties expected of you in a professional manner. In CPTED, ICA certification indicates that you are more than trained; you have put your training to the test in real life experiences and demonstrated competencies.

Anyone with training in CPTED and experience in crime prevention can practice CPTED. However, this will not ensure that a minimum level of competency has been achieved. That is why the ICA Certification Program was created. It is a professional development program for CPTED practitioners.

Virginia CPTED Committee becomes Safer By Design Coalition

In 2001, CPTED advocates and practitioners formed the Virginia CPTED Committee (VCC). The VCC was comprised of practitioners from various disciplines involved in the safe design of places. The goal of the VCC is to present the concepts of CPTED and the efforts being made in the state to the design professionals throughout Virginia. Between 2001 and 2005, twenty-five presentations were made to over six hundred people by this committee; a brochure was produced and distributed and CPTED Guidelines created and distributed to law enforcement and every planning director in the state.

Members of the VCC also provided input on the American Planning Association's (APA) Policy Guide on Security and a number of the committee's comments were incorporated in the final draft that was ratified by the APA Board of Directors in March 2005. The VCPA/VCC has representation on the National Fire Protection Association and supported that organization's Guide for Premises Security in July 2005.

As the various stakeholders worked in partnership, it became evident to the VCC and the VCPA of the need for statewide and national collaboration...

when designing and planning safer places. Consequently, the VCPA and Henrico County Police facilitated and hosted a roundtable in 2005.

This roundtable resulted in the formation of the Safer By Design Coalition. As the various stakeholders worked in partnership, it became evident to the VCC and the VCPA of the need for statewide and national collaboration to ensure consistency

This Coalition is a unique entity as it encompasses a breadth of representation within the design community, law enforcement and state and federal agencies. Thirty members sit on this Coalition, representing 16 different professions. The representatives range from an Assistant Professor of Biology/Director of Arboriculture Program, landscape architects, architects, planners, main street program administrators, the Building Inspector and the Fire Marshal for Virginia, federal policy makers, to CPTED practitioners throughout Virginia.

Accomplishments of the Safer By Design Coalition

Since the Coalition was formed in 2005 and the Statement of Commitment adopted, three statewide design associations in Virginia and the VCPA have endorsed the efforts of the Coalition through formal adoption by the associations or chapter Boards.

Since 2006 the Coalition members efforts to promote the concepts of CPTED have expanded beyond the Commonwealth of Virginia and representatives have trained and presented in other state and national conferences. In 2007 the annual statewide crime prevention conference was held and over 300 people attended.

National recognition of these initiatives resulted in the VCPA winning the State Crime Prevention Association of the Year award by the National Crime Prevention Council at its 8^{th} National Conference in 2007. $\langle XX \rangle$

Determinants of Neighborhood Satisfaction in Fee-Based Gated and Nongated Communities

Neighborhoods unable to adequately satisfy perceived resident needs are susceptible to the migration of their inhabitants to areas that better address their needs. Using the American Housing Survey, the authors examine neighborhood satisfaction and its relationship to perceptions of residents living in both gated and nongated fee-based neighborhoods. The findings indicate that respondent age and the lack of knowledge of crime have the largest positive impact on how the residents rated their neighborhoods. While chronological age may have myriad possible influential factors, the simple knowledge by residents of neighborhood crime has implications for crime prevention and community awareness efforts.

Video Surveillance and Everyday Life

CCTV has become the icon of surveillance, both in popular culture as well as in actual politics. The prothesitc form penetrating our public spheres & spaces are surrounded by much discussion - especially concerning crime & crime prevention. Although much research has been undertaken into the matter, politicians & the general public do still argue on a very simple level about the pro & cons of CCTV & other forms of public & private video surveillance. Rather than an emphatic support or a total denial of CCTV, many people are much more contradictory in their views, often based on a insufficient knowledge of how the technology & whole systems in fact work. These data provide a background to discuss a general framework of surveillance & people's everyday lives, of which CCTV has become one feature.
